NOTICE IS HEREBY GIVEN that on Wednesday, April 17, 2019 at 7:00 p.m. (or as soon thereafter as possible) the City Council of the City of Aliso Viejo will conduct a public hearing to consider the following:

CONSIDERATION OF THE CITY OF ALISO VIEJO'S ADOPTION OF THE 2019-2020 ANNUAL ACTION PLAN FOR EXPENDITURES OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS

INVITATION TO BE HEARD: All interested persons will be given an opportunity to comment on this item at the public hearing. Additionally, the draft 2019-2020 Annual Action Plan will also be available for public review. The review period will begin March 14, 2019 and will end April 12, 2019. The draft document will be available at the City of Aliso Viejo City Hall, at the City of Aliso Viejo Library, and on the City's website at www.cityofaliso Viejo.com. 2019-2020 Action Plan

HUD has yet to publish final 2019 CDBG allocations; however, the City anticipates it will receive an allocation of \$236,000 in CDBG funds for Fiscal Year 2019-2020. Once CDBG grants are announced by HUD, proposed CDBG allocations will be increased or decreased by a uniform percentage based on the final grant amount or as otherwise directed by the City Council.

The proposed use of CDBG funds includes the following:

<u>Proposed Activity</u>	<u>Proposed CDBG Allocation</u>
▪ Public services for lower income persons: Fair housing counseling	\$3,500
▪ Capital improvements: Aliso Viejo Ranch ADA Improvements	\$185,300
▪ CDBG program administration	\$47,200

If you wish to challenge the above project in court, the challenge will be limited only to those issues you or someone else raised at the public hearing or in written correspondence delivered to the City at or prior to the public hearing as described in this notice.
