# **PUBLIC HEARING ITEM NO. 5**

5. <u>PA 12-027: ZONING CODE AMENDMENT WITH VARIOUS CLEAN-UP</u> REVISIONS TO THE CODE

Larry Lawrence, Planning Consultant, presented the staff report.

Questions and discussion ensued regarding patio structure height, Section 15.18.020 Assembly Uses in the BP and PO districts, and Section 15.62.030 Use of Design Standards.

Mayor Garcia opened the public hearing.

 Elizabeth Cobb, Shea Properties, expressed concern and submitted a letter regarding the proposed requirements of clustering units and the dispersal of parking which they believe to be in conflict with high density developments. She stated at a minimum, they would like to recommend the applicability of said standards be defined to exclude high density residential projects that are part of a mixed use development.

There being no further public testimony, the public hearing was closed.

Discussion continued regarding clarification for design standards in Specific Plans to take precedence over the Zoning Code design standards.

MOTION: MAYOR PRO TEM PHILLIPS MOVED AND COUNCILMEMBER FICKE SECONDED TO BRING BACK AMENDMENTS TO ORDINANCE NO. 2012-147 ENTITLED BELOW AS FOLLOWS: 1) TO REMOVE THE PROPOSED VERBIAGE IN SECTION 15.18.020 LIMITING ASSEMBLY USES IN THE BP AND PO DISTRICTS TO 5000 SQUARE FEET; AND, 2) TO ADD NEW VERBIAGE UNDER SECTION 15.62.030C (USE OF DESIGN STANDARDS – EFFECT OF OTHER REGULATIONS) TO CLARIFY THAT DESIGN STANDARDS IN SPECIFIC PLANS ARE TO TAKE PRECEDENCE OVER THE ZONING CODE DESIGN STANDARDS.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ALISO VIEJO, CALIFORNIA, ADOPTING ZONING CODE TEXT AMENDMENT PA 12-027 TO AMEND TITLES 11 AND 15 OF THE ALISO VIEJO MUNICIPAL CODE TO MAKE VARIOUS CLEAN UP REVISIONS

# MOTION UNANIMOUSLY CARRIED.

COUNCIL ALSO DIRECTED STAFF TO COME BACK AT A LATER DATE WITH ADDITIONAL RESIDENTIAL DESIGN STANDARDS FOR PROJECTS WITH A DENSITY OVER 30 DWELLING UNITS PER ACRE AND REVISIT THE PROPOSED 5000 SQUARE FOOT LIMITATION ON ASSEMBLY USES IN THE BP AND PO DISTRICTS.
